Purpose of role:

- Learning the full cycle in general financial control duties including financial reporting, management reporting and regulatory reporting.
- This role includes a study package to complete the ACCA examinations.

Future Primary Responsibilities of Role:

- The reconciliation and control of all Nostro and internal accounts on aquila.
- The reconciliation of suspense balance sheet accounts.
- The maintenance of staff loans including setting-up of loan and payments of loans.
- Payment of suppliers and other invoices including staff expense reimbursements.
- Issuance of re-charge invoices to customers.
- Passing of accounting entries relating to staff cash advances taken.
- Passing of accounting entries relating to staff ATM entries.
- Correctly accounting for VAT on invoices and monthly reconciliation of the VAT GL.
- Process and respond in a timely manner to all customer audit enquiries.
- Any other tasks that may be assigned.
